November Meeting Notes...

The November 12th meeting of the Monroe County R/C Club was called to order at 7:00:09 in the nice warm & dry lobby at Clariti Advanced Vision Correction (thanks Dr. Matt) with nineteen members present.

Bruce & Leslie are waiting on a pathology report & the doctor's next plan of action. Radiation & chemotherapy are in Bruce's future when he has recovered & gained strength from the surgery. Mark Sexton brought in a card & passed it around the meeting room for members present to sign.

Mark reported on the income from the Nebo Memorial Fall Festival Fly-In in October. Since the MCRCC's annual airshow was cancelled due to weather, the donated (& many dated) raffle prizes were raffled off at the Nebo show along with some fine cookies & snacks. Tina Rogers worked with Chris Chandler & made arrangements to sell some of the Coke products that were donated for the MCRCC airshow also. It probably wasn't as big a take as we would have gotten at the Monroe County R/C Club's airshow but Tina & her crew made the best of a bad situation & raised some money for charity.

Plans are being finalized for the December 10th annual club Christmas dinner/meeting. Reservations must be made with Mark Sexton by November 30th if you want in on the buffet at Chapman's. It now looks like the club's contribution to the evening will be around \$650.00. Mark will contact our landlord John Naylor & our neighbors, The Peterson's to see if they would like to attend the dinner as our guests. It was also suggested that Dr. Matt Fornefeld be our invited guest to the dinner as a small token of our appreciation for allowing us to meet in his new office. That motion was passed with no discussion. The evening will begin at 6:00 P.M. (EST) with the appetizers & the buffet will be open at 7:00. The meeting will follow dinner.

Steve Shoop reported on his fly-in / chili cook-off at his home in Brown County on October 18th. There was no wind & plenty

Mark reported that, after reviewing the club's financial reports for 2008, there will be no increase in club dues for 2009. That's good news considering the shape of the economy.

It was reported that Bob Watson suffered some damage at his home from an explosion at the quarry, which is just across the road. They may have to move on short notice. Mark bought his huge picnic table & Jim Scott volunteered to store Bob's airplanes as needed.

There was some damage to the shelter at the club field after the big flood in June. The ground water pushed the posts up around four inches. As the shelter moved, one of the roof braces broke away from its attachment point. Mr. Scott & Mr. Sexton checked the situation & Jim made a repair on the brace. We'll keep an eye on it & see if other measures become necessary or if it will settle back to its original position. Many of the posts along the safety fence have been pushed up by the water also.

This November has not been good for flying model aircraft outdoors. The days have been few & far between when the temp. has been above thirty and the wind has been below thirty at the same time. We are still playing with small electrics in the gym at Paragon Elementary School on Friday evenings from 6:00 to 8:00. All are welcome to come by & see what the indoor aviation thing is all about. It can get a little crowded at times & the helicopters make some dirty air for the light airplanes but we always manage to have a fine time. You can ask one of the regulars if you need directions but you can't get lost because all roads lead to Paragon!

On a recent Thursday evening, a few of us were leaving Nebo Memorial Flying Field in Martinsville (after dark) when we saw Mark Curtis's car sitting along 252, just outside Martinsville, with the flashers on. Mark Sexton & I stopped to see if Mr. Curtis needed any help. A giant deer had picked a fight with Curtis's car & lost. It put up a good fight & tore up the front of Mark's car (along with the hood) pretty good. While we were waiting for the police to arrive & finish the deer, we were talking about the clear sky & full moon. Strange things seem to happen when the moon is full. Deer jump out into traffic & it seems that many people drive a little strangely also. It was at that moment three vehicles came around the blind corner on 252 toward town. The first speeding car saw all the flashers & applied the brakes. The second car, that was following too closely, slammed on it's brakes to avoid the first car. The third car in the group was speeding, following too closely, & not paying attention. He slammed on his brakes & cut the wheel. The car left the road & headed directly toward where we were standing. It was a free-for-all as we scratched & clawed to get out of the way! The young man in the hotrod was totally out of control as he missed us by inches & plowed into a utility pole. On his way to the pole he ran over & killed the
